#### **Annual Meetings**

#### Newsletters

We encourage all homeowners to sign up to receive our quarterly e-newsletters, which are sent via email and available on the website. By registering on our website, you will receive the newsletters.

#### Rentals

If you plan to rent your home throughout the year, please note that You as the homeowner CANNOT use the Antilles facilities during the term used by your tenants.

#### **Dumpsters**

The dumpsters are for club use. Please ask for permission if you need to use the dumpsters. Please flatten ALL Cardboard, there are no pizza boxes allowed in the Dumpster, ABSOLUTELY no Chemicals, Electronics, Paints, Hazardous Materials, Tires, and/or Mattresses, please call waste management for special days to get rid of Hazardous Materials through the County. Finally, nothing should be left outside of the DUMPSTER.

#### Pets

Having a pet is a responsibility. Owners are reminded that Owners are responsible for their pet's behavior, (Consistent barking or aggressive behavior), Pets need to always be leashed per Collier County Code, ALL pet waste MUST be picked up IMMEDIATELY and disposed of in provided stations throughout the property, NO animals allowed on Pool Deck nor in Clubhouse and Owners will be held responsible for Tenants animal's damage. For any information, regarding pets, their behavior, etc., please refer to your bylaws/covenants.

You may roll your carts to the curb after 6pm the night before collection but no later than 6am the morning of collection.

## **Deed Restrictions**

Antilles is a Deed Restricted Rules and Regulations Community. The Deed Restrictions of Antilles specify how each resident must maintain their property. The Antilles Restrictions are enclosed with this letter and are also found on our owner portal website. Please familiarize yourself with these restrictions to ensure compliance within the community and to maintain the beautiful and desired place to live. Listed below are some of the areas of restriction that need to be adhered to:

- Garbage/recycle containers
- Maintenance of property
- No Trade, Business, or Profession
- Nuisances
- Outside storage
- Parking
- Signs/displays

## **Violation Protocol**

When a deed restriction violation is received and subsequently confirmed (via date stamped photo, eyewitness, or audio, if appropriate) a Notification Letter is sent to the violator indicating the corrective action necessary to avoid being fined and or being turned over to City Code Enforcement. The allotted time for the correction will be stated in the letter. It is the resident's responsibility to call Property Management by Elite in the event a violation cannot be resolved in the allotted time.

## Architectural Review Board Request (ARB)

An ARB is an Architectural Review Board request for new construction, additions, alterations, or improvements made to your home. ARBs must be approved PRIOR to beginning work. For additional information or to obtain the ARB form go to <u>www.antillesnaples.info</u>.
